### 4. Significant deviation in EPS, NAV and NOCFPS:


The company has also informed that, reason for significant deviation in EPS, NAV and NOCFPS as follows: EPS has been decreased due to fall in production for closure of Mill in 3(three) consecutive months and adverse effect of COVID-19, Write off Advance Income Tax, loss of stock sale and financial cost. NAV has been decreased due to Net loss after Tax, decrease in the company's Retained Earnings and Assets. NOCFPS has been decreased due to lower sales & collection in the year under review.

### 5. The Board also decided that, under compiling current circumstances, the management decided to close down the operation of the factory until further notice.
